Terms

1. Payments by the plant to NPCA are non-refundable.
2. Plants may be charged for additional travel expenses if the evaluation is expedited or scheduled within two weeks of initial contact by the NPCA staff engineer.
3. If the plant is located outside the 48 contiguous states or outside in the Canadian provinces, the plant will be responsible for any additional travel or personnel expenses incurred. Approximate charges shall be established in writing prior to the visit on a case-by-case basis.
4. Any plant canceling or changing a confirmed visit will be responsible for all costs incurred to cancel or modify travel arrangements.
5. Payment in full is required at the time of application
6. Merger, Modification and Choice of Law

This Contract integrates and merges the entire Contract of the parties hereto, and extinguishes all prior proposals, representations, negotiations, assurances and agreements. Plant's signature below attests to the accuracy of representations made by the Plant in the foregoing Contract. If a court should find that any language of this Contract is unenforceable, that language shall be deemed deleted and the remainder of the Contract shall remain in force. The construction and enforcement of this Contract shall be governed by the law of the State of Indiana and the state courts of Hamilton County, Indiana shall have sole jurisdiction to adjudicate any claims, disputes or controversies arising out of or in conjunction with this Contract or the breach thereof. Plant for that purpose submits itself to the personal jurisdiction of the state courts of Hamilton County. In the event of litigation to enforce the terms of this Contract, Plant shall pay all expenses, including without limitation attorneys' fees and expenses, incurred by NPCA.
